## Important Guidelines

Signatures below indicate my/our understanding of and support of the following:

- Individuals attending Central Holmes Christian School dances must be between the ages of 12 and 19. All CHCS rules and regulations are in effect at all times. Appropriate disciplinary action will be taken for failure to follow rules and regulations. Expelled or suspended students may not attend CHCS dances.
- CHCS Alumni over the age of 19 must be approved by the Headmaster.
- All individuals entering a Central Holmes Christian School dance may be required to present an appropriate picture ID.
- All CHCS students and their guests may submit to an alcohol breathalyzer test to gain admission into any school sponsored dance under the supervision of the CHCS administration.
- If a student or guest tests positive for alcohol, the student or guest will be denied admission into the dance, and a parent/guardian will be required to pick the student up from the dance. A negative test for alcohol will allow the student admission into the dance.
- The Central Holmes Christian School student and his/her guest must enter and leave the dance together. The CHCS student is responsible for the behavior of his/her guest and is subject to disciplinary action for failure to abide by the rules and regulations.
- Parents will be contacted to pick up their child due to misbehavior at the dance.
- All students and guests are required to sign in and out of the dance.
- All individuals must enter the dance by 10:00 p.m.; the doors will be locked thereafter. Individuals leaving the building must leave the premises and are not allowed to re-enter.
